#### Impacts of Russia's war of aggression against Ukraine

War has significantly impacted the innovation and creativity sector and ecosystem in Ukraine



#### Assessment of impacts of the war on Ukraine's innovation and creativity sector and IP ecosystem

#### WIPO International Bureau, document A/64/8, June 7, 2023

Since 2014 **nearly 26%** of the territory of Ukraine remains occupied.

Some **10 million Ukrainians remain displaced**, including **3.7 million within Ukraine** and a further **6.3 million** who have sought safety abroad.

In 2023, Ukraine overcame 6,000 air alerts.

Damaged or destroyed more than **190,000 civilian infrastructure facilities** – 152,587 residential buildings, 3,618 educational and 872 medical institutions 641 cultural and 198 religious buildings, and 7,936 water and electricity networks. Damaged or destroyed **2,093 objects of cultural infrastructure**, including 746 libraries, 120 museums and galleries, as well as 1169 objects of cultural heritage. According to UNESCO, nearly **9 bln USD** will need to be raised between 2024-2033 to finance the recovery and reconstruction efforts.

The environmental crimes committed by Russia are causing long-term damage to our country. It will take decades, if not longer, to recover. The current damage to Ukraine's ecosystem is estimated at **65 bln USD**.









On **25 June** the ECHR found the Russian government responsible for the administrative practice of human rights violations in the TOT of the Autonomous Republic of Crimea and the city of Sevastopol.

Ukraine is **one of the most mined countries**: since 2022 approximately 174,000 sq.km of Ukrainian territory of which 14,000 sq.km are water areas, have been contaminated with Russian mines and UXO, making **139,000 sq.km potentially dangerous**. ~6 mln people in Ukraine deal with mine danger to their lives and health.

The **historic centers** of Lviv and Odesa have been damaged as a result of deliberate Russian actions. According to the **Declaration of the Congress of Local and Regional Authorities of the Council of Europe** on Russia's Destruction of Ukraine's Cultural Heritage, these attacks may be viewed as an attempt to **destroy Ukrainian identity**, which falls under the definition of genocidal policy



# IP Institutional reform in Ukraine



Ukraine has completed the IP institutional reform and continues to update and improve the IP protection and enforcement system.









**On June 16, 2020**, the Law of Ukraine "On Amendments to Certain Laws of Ukraine on the Establishment of the National Intellectual Property Authority" No. 703-IX was adopted.

**On August 24, 2022** UANIPIO was registered respectively to the Resolution of the Ministry of Economy of Ukraine No. 2673 of August 22, 2022.

**On November 8, 2022** UANIPIO was empowered with the functions of the National Intellectual Property Authority, respectively to the Resolution of the Cabinet of Ministers of Ukraine No. 943 of October 28, 2022.

**On July, 2023** the PCT Union Assemblies have approved that UANIPIO continues to perform the functions of the International Searching Authority (ISA) and the International Preliminary Examining Authority (IPEA).

#### **Industrial property**

Compared to 2022, the number of applications increase is the following:

for inventions: +5.5%



for utility models: +47.4%



for industrial designs: +34.8%



for trademarks: +55.4%

In 2023, 8,580 applications for the state registration of copyright in a work were received, which is **49.5%** more than in 2022.

And the number of contracts concerning the author's right in a work is **68.8%** higher
